Regarding Travelling To School When A Weather Warning Has Been Announced

Dear Parents and Guardians,

We would like to express our sincere appreciation for your continued understanding and cooperation in the educational activities of our school.

We would like to inform you that, due to changes in the disaster weather information issued by the Japan Meteorological Agency, Chiba City Municipal Schools will partially revise the criteria for temporary school closures in the event that weather warnings are issued, effective May 29, 2026.

Accordingly, in order to prioritize the safety of our students, we ask for your understanding and cooperation regarding the revised measures as outlined below.

Procedures

1 Measures to be Taken When a “Storm Warning,” “Blizzard Warning,” or a “Special Warning” for storm, blizzard, or heavy snow is issued, or when a “Level 4 Hazard Alert” or “Level 5 Emergency Warning” related to heavy rain flooding, landslides, or storm surges is announced.

If, as of 2:00 p.m., a “Storm Warning,” “Blizzard Warning,” or a “Special Warning” for heavy rain, storm, blizzard, or heavy snow is in effect for Chiba City, or if a “Level 4 Hazard Alert” or “Level 5 Emergency Warning” related to heavy rain flooding, landslides, or storm surges remains in place, the school will be closed for the day.

- (1) If a “Storm Warning,” “Blizzard Warning,” or a “Special Warning” for storm, blizzard, heavy snow, etc., or a “Level 4 Hazard Alert” or “Level 5 Emergency Warning” related to heavy rain flooding, landslides, or storm surges is lifted by 2:00 p.m., the school will not be closed. Please check the weather conditions and have your child attend school without taking unnecessary risks.
- (2) If a “Storm Warning” or a “Level 4 Hazard Alert,” etc., is issued after students have already arrived at school, dismissal times may be changed and students may be sent home early.

2 Procedures for when an “Evacuation Order” is announced

- (1) If there is an “Evacuation Order” as of 2 p.m., the situation and location of the school will be considered before deciding if the school will temporarily close.
※If the school temporarily closes, the “Suguru Mail” system will be used to contact the parents/guardians about the situation.
- (2) In the case that the “Evacuation Order” has been lifted by 2 p.m., the school will open as usual. Please check the weather conditions to see if it is safe before sending your child to school.

3 Procedures for when warnings for heavy rain and snow are announced (excluding storm and blizzard warnings)

In this instance, the parents/guardians will make the decision if they want to send their child to school or not. If the parent/guardian chooses not to send their child to school when there is a heavy rain or snow warning, the child will not be marked absent or late.

4 Ensuring the children’s safety

In the case of an emergency disaster situation such as heavy rain, a storm, heavy snow or any other emergencies, we ask for your cooperation with the following guidelines at home.

- (1) There may be unexpected dangers when travelling to school during an emergency situation such as heavy

rain, a storm or heavy snow. Please be mindful of any dangerous places or circumstances which could arise. Don't force your child to attend school if it is too dangerous.

(2) If the advisory or emergency announcement has been lifted and the heavy wind or rain has subsided, please check that it is safe to travel to school before doing so.

(3) If your child arrives late or early to school due to heavy rain, a storm or heavy snow, please ensure to let the school (or the class teacher) know.

< Points to be aware of when collecting your child from school >

- Parents/Guardians should check the communication from the school via the “Suguru Mail” system before coming to collect their child. The child will be kept at school until a parent/guardian arrives.
- If a someone else comes to collect the child instead of the parent/guardian, it is essential that the parent/guardian lets the school know in advance. If there is no prior notice given to the school the child will not be able to leave.

If a “storm warning” or “snowstorm warning” is announced, it refers to the announcement for the situation in Chiba City.

For weather reports, please check the media such as the TV or the internet. In addition to the Chiba City Safety and Security Mail and the Yahoo! Disaster Information app, please check the “disaster prevention information for your city” website of the Japan Meteorological Agency.
